**Project measures:**

The Regional Water Company "KRU Gjakova" (RWC Gjakova) has received financing from KfW Development Bank toward the cost of the "Sewage Disposal in South-West Kosovo – Phase V+VI", and intends to apply part of the proceeds toward payments under the contract for "Works Contract 1.2: Rehabilitation of the Sewerage Network (Gjakova)".

The purpose of the Program is to improve the sewage disposal in the city of Gjakova. This is to contribute to the protection of surface and ground water resources as well as the improvement of the living conditions of the population in Gjakova.

**Requested services:**

About 8,17 km of existing Sewer Lines (from DN 250 to DN 400 and depth between 2 – 5 m) and about 240 manholes shall be replaced/rehabilitated at their same location within various roads and dense urban sites, which requires beside common safety measures (ESHS management) and others demolition, handling of wastewater and traffic management. Further it must be noted and considered, that regarding supply and installation of materials certain material are on stock of the Employer from previous Phase III financed by KfW, which must be used by the Contractor within this Works. Also the supply of one combined Flushing & Suction Vehicle (tank volume: 3.5 m³) is included. The Time for Completion of the Works is 547 calendar days, followed by the Defects Notification Period of 365 calendar days.

Eligible companies with qualified personnel, appropriate facilities and experience (general and local) in the execution of comparable projects are invited to submit bids.

Bidding will be conducted by means of the International Competitive Bidding procedure with qualification as specified in the KfW Guidelines for Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries ("KfW Guidelines") by "Single-Stage Selection" and "Two-Envelope-System".
